

We are glad to inform you that 12-14 September 2019 in Frankfurt there will be a legal event organized by European Center for Legal Cooperation, 110 Ave. Jean Jaures, 67100 Strasbourg (Tel.: +33 788 007 559). The participation is free for lawyers of the Frankfurt Bar interested to create more contact with potential clients from Russia, Kasachstan and Ukraine in Frankfurt.

It'll be a 3 days event (12-14 September) for Russian speaking lawyers from Russia, Ukraine and Kasachstan.

The program will include:

1) the topics about different fields of German law (immigration law, law law, family law etc). Please find exact titles in Russian:

- *Миграционное право Германии. Получение и продление ВНЖ и ПМЖ. Особые категории.*
- *Юридическая практика в области слияний, поглощений и инвестиций в частные компании в Германии.*

2) CECJ Speed legal Networking (09:00-13:00 on 13 September). Interactive format allows the participants to meet all Russian professionals interested in establishing direct contacts with German lawyers for future projects.

- Russian speaking lawyers from the Frankfurt Bar who are interested to make 1h30 presentation in Russian for one of the topics described in point 1 (in total 7 lawyers may be less if one lawyer could talk for two subjects).
- Russian speaking and not Russian speaking lawyers from the Frankfurt Bar (max 25 person) interested to work in the future with Russian clients to participate CECJ Speed legal Networking (09:00-13:00 on 13 September).

During this event you'll be able to meet 25 Russian lawyers interested in cooperation with German lawyers for investments matters, civil and criminal cases of Russian clients in Germany.

Language: Russian/German (consecutive interpretation)

The format of the event:

All the participants take their seats at some round tables. At every table there will be 5 lawyers from Russia, Ukraine, Kazakhstan and 5 lawyers from Germany. Each table will be managed by an interpreter. During first 40 mins all 10 persons at each table, one by one, will be able to shortly, not more than 2 mins, present themselves and their business. Once first 40 mins pass there will be a 5 mins break for the lawyers from Germany to change their seats at the tables clockwise. Consequently, by changing all 4 tables every participant will be able to communicate with all the foreign lawyers and identify mutual interests and future business opportunities.
